# DRAFT Minutes of the Meeting of the Parish Council held on on Tuesday 7 February 2017 at 7:30 pm in Blackawton Village Hall

#### 1. Apologies

Apologies were received from Devon County Councillor Hawkins.

#### 2. Declarations of Interest

Cllr Rake declared a disclosable pecuniary interest in Item 11.2 (payment of Garra Delta invoice) and Cllr Perry declared a DPI in Item 7.1 (SHDC Planning Goodridge decision).

## 3. Minutes of Previous Meeting

It was resolved to approve the minutes of the Meeting held on 10 January 2017.

## 4. Air Ambulance night landing sites in Blackawton

Steve Thomas, who has taken the community lead on this project, discussed the project, the proposed sites, the requirements of the location, and cost (£2,700 plus cables). The works include installation of a tower and lighting. A grant is available to carry out the works, including the digging of a trench, however purchase of equipment must be funded by communities. Nine sites in Blackawton have been evaluated by Devon Air Ambulance. The community field (Worm Charming field) and Mrs Bailey's field have been evaluated as equal first preference. Both are good central sites.

The community field is owned by the Playing Field Association. It has parking for a land ambulance in the Village Hall car park. It would require a lighting tower which could go in the corner of the field next to the BT phone line. It would be necessary to remove all fruit trees and the fencing around the top end of the allotments would need to be moved back towards the polytunnel. The earth bank would be left as is.

To use Mrs Bailey's field a land ambulance would have to park in the lane and a new power supply would be needed. The use of the field for livestock would be restricted. It was agreed that both first preference sites would be considered in the first instance. The Playing Field Association meets in two weeks. The Clerk will write to the owner of Mrs Bailey's field. The Devon Air Ambulance contact, Toby Russell, will be invited to the Annual Parish Meeting.

#### 6. Report from South Hams District Councillor

The Local Plan will go to the Council for adoption in three weeks. There will then be a six week public consultation, before the Plan goes to the Inspectorate for approval. It will be recommended that the Local Authority Controlled Company is not pursued because of the cost of moving staff pension funds. SHDC will remain open to alternative approaches. The Clerk will liaise with Cllr Hicks to arrange a visit from a Planning Officer.
