a) Buddle Holes

The Clerk will then refer the case to DCC and work to publicise the vital importance of buddle holes to maintain the safety of the roads.

7. Devon Air Ambulance night landing site in Blackawton

The Playing Fields Committee has agreed to the use of the community field subject to the replacement of the apple trees.

Steve Thomas reported on progress made with the project. Obtaining planning permission for the lighting column and insurance needs to be planned. The funds raised for the project have almost reached the £3,000 target. Toby Russell [Devon Air Ambulance] will provide a detailed cost and specifications to the Annual Parish Meeting. Someone has agreed to remove and replace the trees in exchange for the wood. Whether the BT cable is a hazard which needs to be addressed is to be clarified.

BPC can submit the planning application for the lighting tower and it is being checked whether it can assist with insurance.

8. Cemetery bin
