

## **Blackawton Cemetery Charges**

The fees set out below apply to residents of the Parish of Blackawton. Fees will be doubled for qualifying former residents (please see the Blackawton Cemetery Regulations for the definition).

### **PART 1: EXCLUSIVE RIGHT OF BURIAL IN EARTHEN GRAVES**

i)	in an earthen grave 7 feet by 3 feet	£125.00
ii)	in an earthen grave 3 feet 6 inches by 2 feet	£65.00
iii)	of cremated remains in an earthen grave 2 feet by 1 foot 6 inches in Section E of the Cemetery	£65.00
iv)	the issue and registration of duplicate Deed of Grant of Exclusive Right of Burial.	£20.00

### **PART 2: INTERMENTS**

#### 2.1 Interment in a grave in the lawn memorial area of the Cemetery

i)	of the body of a stillborn child whose age at time of death did not exceed 6 months	£40.00
ii)	of the body of a child whose age at time of death did not exceed 12 years	£95.00
iii)	of the body of a person whose age at time of death exceeded 12 years	£125.00

2.2 Interment of cremated remains in a grave in Section E of the cemetery £55.00

2.3 The exhumation of a body, exclusive of re-interment fees £120.00

2.4 The scattering of ashes in the Garden of Remembrance Section A of the Cemetery or on a family grave Nil

### **PART 3: MEMORIALS, TABLETS AND INSCRIPTIONS**

#### 3.1 For the right to place on a grave:

i)	a memorial not exceeding 3 feet in height and 2 feet in width	£60.00
ii)	in Section E of the Cemetery a single recumbent tablet not exceeding 18 inches by 15 inches	£60.00

3.2 For each subsequent inscription after the first. £40.00

The fees indicated for memorials and tablets include the first inscription.

**PART 4: CHURCH FEES**

The above fees are exclusive of Ministers' and related Church fees. These are made directly to the Church.

**PART 5: APPROVAL**

Permission must be obtained in advance for all interments, scattering of ashes of cremated remains, and for the right to erect a memorial, tablet and/or any other permanent adornment to a grave.

All applications for burial and for permission to carry out any work on memorials or tablets must be made to the Clerk to the Parish Council on the appropriate form.

All relevant information required by the Council in respect of each request must be provided before approval can be given.
